State Law section 87-2-511(4) MCA, prohibits the use of outfitter sponsored license for bookings in which the client does not hunt with the outfitter or a licensed guide working under the supervision of the outfitter. Certification can be provided only when a deposit fee has been received. The making of a false statement by either the outfitter or the client on this form may subject the outfitter or client to criminal charges under Section 87-2-106, MCA. Certifications submitted with facsimile or photocopies of outfitter and client signatures will not be accepted.
